Criminal Justice Major/Minor Advising Guide

The Criminal Justice program offers a major and minor in Criminal Justice. The Criminal Justice major offers students a quality liberal arts experience. Coursework introduces students to theories and methods, while providing a comprehensive overview of the U.S. criminal justice system. Students also have the opportunity to take courses from experienced practitioners through CJUS offerings. The major prepares students for employment in areas such as law enforcement, court services, corrections, and social justice work related to the criminal justice system. The major also prepares students for graduate school and law school. Students complete eleven (11) courses for the major and five (5) courses for the minor.

<u>Double Majoring in Sociology and Criminal Justice:</u> The Department of Justice & Society Studies also offers a major and minor in Sociology. Students choosing to double major in Criminal Justice and Sociology are limited to the number of courses that can be applied to both majors: SOCI 100, 210, 220 and **two** of the following 312, 344, or 346.

Combining a Criminal Justice major with a Sociology minor: May not share more than two courses (8 credits).

<u>Double Majors with Psychology</u>: Students who have a double major in criminal justice and psychology and complete SOCI 210, PSYC 212, and STAT 220 may receive a waiver for SOCI 220 by contacting the department chair.

<u>Licensure as a Police Officer</u>: Students who intend to take the Minnesota Peace Officers licensing examination must take CJUS 345 (Police Operations) and also complete SOCI 251 and PSYC 111. Students must also obtain First Responder certification. Contact Dr. Gladney, the department's Law Enforcement Education Coordinator, with any questions about the licensure and required courses.
