



UNIVERSITY OF ST. THOMAS - MINNESOTA

Report dated October 8, 2021, for the quarter ended September 30, 2021

1. On January 17, 2021, the University of St. Thomas received \$7,468,750 under Section 134(a)(1) of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA). Pub. L. No. 116-260 (December 27, 2020). Under Section 314(d)(5), institutions must use at least the same amount of funding to provide emergency financial aid grants to students as was required under Section 18004(a)(1) of the CARES Act. For the University of St. Thomas, this amount was \$2,502,601. Per instructions from the Department, St. Thomas drew down CRRSAA funds within 90 days of the supplemental award date, signaling our acknowledgement and acceptance of the award.

On May 25, 2021, the University of St. Thomas received \$13,531,348 under section 2003 of the American Rescue Plan Act of 2021 (ARP) Pub. L. 117-2 (March 11, 2021). Under Section 2003(7), institutions must provide emergency financial aid grants to students in an amount equivalent to the sum of two amounts: 50 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(A)-(D) and 100 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(E)-(F). For the University of St. Thomas, this amount was \$6,766,097. Per instructions from the Department, St. Thomas drew down ARP funds within 90 days of the supplemental award date, signaling our acknowledgement and acceptance of the award.

2. St. Thomas has received \$2,502,601 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA(a)(1) award.

St. Thomas has received \$6,766,097 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the ARP(a)(1) award.

3. As of September 30, 2021, all Emergency Financial Aid Grants totaling \$2,502,601 have been distributed to St. Thomas students under the CRRSAA award.

As of September 30, 2021, Emergency Financial Aid Grants totaling \$1,970,034 have been distributed to St. Thomas students under the ARP award.

4. St. Thomas estimates that 8,520 students were eligible to receive Emergency Financial Aid Grants under CRRSAA.

St. Thomas estimates that 15,728 current and former students are eligible to receive Emergency Financial Aid Grants under ARP.

5. As of September 30, 2021, Emergency Financial Aid Grants under CRRSAA have been distributed to 2,104 students. An additional 392 Emergency Financial Aid Grants were awarded under the CRRSAA institutional award.

As of September 30, 2021, Emergency Financial Aid Grants under ARP have been distributed to 1,459 students.

6. As of September 30, 2021, St. Thomas has used the following methods to determine which students receive the Emergency Financial Aid Grants and how much they receive:

CRRSAA: St. Thomas identified students with the most need as those who filed a FAFSA for the 2021 aid year and had an Estimated Family Contribution (EFC) between \$0 and \$15,000. Grant amounts ranged from \$250 to \$1,600 with the larger grants going to full time students with lower EFC levels.



ARP: St. Thomas offered two programs for ARP. The first program identified current or former students who were facing course cancellations due to past due student account balances or those who were enrolled at any time during the COVID-19 pandemic who had registration/transcript holds due to past due student account balances. These students were invited to apply for a grant and a committee reviewed each applicant's file to make a decision on whether to grant the student an award and how much to grant. Awards from this program ranged from \$1,000 to \$6,495. Students could choose to use the grant for any eligible purpose under ARP; they were not required to apply the grant to past due student account balances. The second program is providing grants to currently enrolled students, with most of the funding allocated to domestic, undergraduate students who demonstrate exceptional financial need. Need was determined primarily based on students' FAFSA results and corresponding Expected Family Contribution (EFC). Based on the number of eligible recipients, the emergency grants were tiered in amount, such that students with the lowest EFC's will receive the largest grants. Awards range from \$250-\$2,500 depending on several factors, including EFC and enrollment status (e.g., part time vs full time).

7. Students who received direct CRRSAA emergency grants in 2021 were notified via email on February 17, 2021. In addition, an article was posted internally on February 17, 2021 to the University of St. Thomas community at large. Attached are examples of these notifications.

Students who were eligible to apply for the first ARP program were notified via email on July 14, 2021. For the second ARP program, students who received direct ARP emergency grants in 2021 were notified via email on September 27, 2021. In addition, an article was posted internally on September 27, 2021 to the University of St. Thomas community at large. Attached are examples of these notifications.

As part of the 2021 Coronavirus Response and Relief Supplemental Appropriations Act passed by Congress in December 2020, St. Thomas will receive additional relief funds to provide emergency grants to students with exceptional financial need. In addition to having exceptional need, students receiving the grants must be eligible for federal financial aid. The grants may be used for students' costs of attendance at St. Thomas, or for emergency costs that arise due to the coronavirus.

Based on current guidance from the Department of Education, St. Thomas will be issuing emergency grants to eligible undergraduate, graduate and Dougherty Family College students who have demonstrated exceptional need as evidenced by their FAFSA Expected Family Contribution (EFC).

Based on the number of eligible recipients, the emergency grants will be tiered in amount, such that students with the lowest EFCs will receive the largest grants. Awards range from \$250 - \$1600, depending on EFC and whether the student is enrolled full-time or part-time.

Because awards are based on the above criteria, there is no separate application process for this grant. Read the [Frequently Asked Questions](#) for additional information.

Students who will receive an emergency grant will be notified by email and receive funds by check or direct deposit. This emergency grant is a one-time, non-renewable grant and is not considered financial aid.

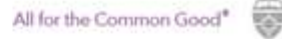

The University of St. Thomas understands that the COVID-19 pandemic has caused unfortunate financial hardship for many. In response to the pandemic, the federal government is providing emergency funding to colleges and universities through the Higher Education Emergency Relief Funds program (HEERF III). Some of the HEERF III funds are designated for emergency grants to current or former students of the colleges and universities receiving the funds.

St. Thomas is now accepting applications for HEERF III emergency grants. These grants can be applied toward the cost of attendance (including current and past due tuition, room, board, books, supplies and miscellaneous expenses to attend St. Thomas) or for other costs students have incurred related to the COVID-19 pandemic, such as food, housing, health care (including mental health care) or child care. It is up to the student to determine how to use the HEERF III emergency grant within these allowable uses.

To be eligible to receive a HEERF III grant, a student must have been enrolled at St. Thomas at any point on or after March 13, 2020 (the date the COVID-19 national emergency began) and must demonstrate exceptional financial need. All students who meet these criteria are eligible to apply for a HEERF III emergency grant, regardless of whether you have completed a FAFSA or are eligible to apply for or receive federal or state financial aid. Students eligible to apply for HEERF III emergency grants include U.S. citizens, permanent residents, refugees, asylum seekers, Deferred Action for Childhood Arrival (DACA) recipients, other DREAMers, similar undocumented students and international students.

As part of the 2021 American Rescue Plan Act passed by Congress in March of 2021, St. Thomas has received additional relief funds under the Higher Education Emergency Relief Fund (HEERF III) to provide emergency grants to students. Students may use the grants for their costs of attendance at St. Thomas, or for emergency costs that arise due to the coronavirus.

St. Thomas will be issuing the emergency grants to eligible graduate and undergraduate students (including Dougherty Family College students). The grants will begin to be issued around mid- to late October.

Consistent with federal requirements and guidance, most of the funding will be allocated to domestic undergraduate students who demonstrate exceptional financial need. Need will be determined primarily based on students' FAFSA results and corresponding Expected Family Contribution (EFC). Based on the number of eligible recipients, the emergency grants will be tiered in amount, such that students with the lowest EFC's will receive the largest grants. Awards will range from \$250-\$2,500 depending on several factors, including EFC and enrollment status (i.e., part time vs full time, etc.).

Students who will receive an emergency grant will be notified via email and will be allowed to choose to have the funds applied to their student account balance or to receive the funds via check or direct deposit.
